MAYOR HAPPENINGS

Support for Prosecution of Felony Level Drug Possession

Our County Prosecuting Attorney, Adam Cornell, asked Police Chiefs and Cities to support his request for more resources so he can prosecute for lower level felony drug offenses.

This week, the Monroe City Council sent the attached letter to ask Snohomish County to support Mr. Cornell and give him the resources he needs to prosecute lower level felony drug offenses. Mayor Thomas and the Monroe Police Department thank our City Council for their support!

Because the County does not prosecute for lower level drug offenses, at the direction of Mayor Thomas, and with full support of the City Council, Monroe pays for costs including prosecution, public defense, and incarceration, so that people found with smaller amounts of drugs will be held accountable. State law does not allow Cities to prosecute people for felonies, so the City can only prosecute these felony charges as misdemeanors. Misdemeanors carry lighter sentences than felonies.

Mr. Cornell, our County Prosecutor, has asked for the resources to prosecute these offenses as felonies. As felonies, the burden of cost for prosecution and incarceration is paid for by the County instead of the City AND felony charges can result in stiffer penalties than misdemeanors. 
