The Amendment will be considered by the Planning Commission at a public hearing, which forwards a recommendation to the City Council. The City Council is the final decision authority for legislative actions in the City.

This is a non-project action that proposes an amendment to chapter 22.12 MMC Definitions to add/remove/update definitions to be consistent with the current code and state guidelines.

In 2019, the City adopted the UDR – title 22 MMC – to replace the prior development code in MMC titles 17, 18, 19, 20, and 21. When adopting the new UDR, it was decided to keep existing pre-UDR definitions until they could be properly updated. Consequently, the new UDR included an amalgamation of complete and implementable definitions, outdated definitions, and incorrect definitions. On September 9th, 2021 the City passed Interim Ordinance 008-2021, and later Interim Ordinance 014-2022 on May 10th, 2022, to provide interim definitions consistent with the new UDR until such definitions could be properly updated.

The proposed amendment seeks to update terms to ensure consistency/organization of the existing code (MMC 22).
