Lighting Fees: \$20.00 per hour.

Tournament Fees: A flat rate will be charged, which includes user and maintenance fees. A deposit is required.

Deposits: \$150.50 for in-City residents, or \$175.00 for outside residents (nonrefundable).

Fees: Remaining fees are due within five working days following the tournament.

Schedules: Must be received two weeks prior to the tournament. Games will not be scheduled before 9 a.m.

Concessions: Request for concession sales must be approved by the Parks and Recreation Director if there is no current concession contract.

Other Regulations:

1. Drinking alcoholic beverages in city buildings or on city park grounds is prohibited.
2. All groups must leave the facility in satisfactory condition. Violators must accept the director's estimated damage appraisal.
3. The user shall comply with all applicable anti-discrimination and affirmative action ordinances, laws and statutes.
4. The City of Monroe reserves the right to revoke any permits when deemed advisable in the department's best interest.

Rainouts: The City of Monroe will determine field conditions by 3:30 p.m. on weekdays. Umpires will make the call on weekends. Call the rainout information line at 360-863-4508 for field conditions. If the message has not been updated, assume the fields are playable.

Cancellations: Cancellations must be made at least 30 days prior to event. Refunds will be issued minus a \$20.00 administrative fee. No refund will be given if cancellation is made less than 30 days before the event.

Returned Checks: A \$30.00 fee is charged for all returned checks.

Agreement, Release and Indemnification

The person or organization entering into a use agreement with the City of Monroe (herein referred to as the "city") for the use of City of Monroe's facilities or equipment described above (collectively "the facilities") certifies that the information given in this application is current and correct. The undersigned further states that he or she has the authority to make this application for the applicant and agrees that the applicant will observe all rules and regulations. The applicant further agrees to reimburse the city for any damages arising from the applicant's use of said facilities. Any accident involving injury to participants or damages to the facilities occurring during the use of the facilities will be reported to the city immediately.

FURTHERMORE, the applicant agrees as follows:

I am aware of and expressly assume all of the various risks of serious injury and/or death associated with or arising out of the use of the facilities.

In consideration for granting this request, and being fully aware of all of the risks, I hereby RELEASE the City of Monroe and its officials, employees, volunteers and agents ("the Released Parties"), and agree to waive any right of recovery that I AND/OR THE ORGANIZATION, AS APPLICABLE, may have, including the right to bring a legal claim, cause of action, or lawsuit for any bodily injury, death or other harmful consequences in any way arising out of use of the facilities. I understand that this release extends to all claims of any kind and every nature, known, unknown, suspected or unsuspected, in any way arising out of or related to use of the facilities.

I agree to defend, indemnify and hold harmless the released parties from and against any and all claims, suits, actions, or liabilities for injury or death of any person, or for loss or damage to property, which arises out of the use of the facilities or from any activity, work or thing done, permitted, or suffered by applicant in or about the facilities, except only such injury or damage as shall have been occasioned by the sole negligence of the released parties.

INSURANCE

The applicant is required to procure and maintain for the duration of the use or rental period insurance against claims for injuries to persons or damage to property which may arise from or occur in connection with the use of the facilities and the activities of the applicant and his or her guests, representatives, volunteers and employees.

Accordingly, the applicant shall provide proof of general liability insurance, with minimum limits of \$1,000,000.00 per occurrence and \$2,000,000.00 aggregate, and name City of Monroe as an additional insured by using ISO Additional Insured-Managers or Lessors of Premises endorsement CG 20 11 or an endorsement providing at least as broad coverage on said policy. The insurance policy shall contain or be endorsed to reflect that the applicant's insurance coverage shall be primary insurance as respect the city. Any insurance, self-insurance, or self-insured pool coverage maintained by the city shall be excess of the applicant's insurance and shall not contribute with it. (Low-cost Special Events Liability Insurance may be available through the city's carrier.) For athletic events, the general liability insurance shall include coverage for participant liability with limits of not less than \$1,000,000.00 per occurrence. The user shall provide a certificate of insurance evidencing the required insurance, including the additional insured endorsement, before using the Premises.
